

OFFICIAL SWEEPSTAKES RULES

Limitations on Eligibility/Availability of Sweepstakes

This sweepstakes is void where prohibited by applicable law. The Sweepstakes is open and offered only to legal residents of the 50 United States and the District of Columbia age 13 or older. Winners may be required to sign an Affidavit of Eligibility as a condition to the delivery of the applicable prize. How to Enter
